### Glossary

This glossary is extracted from New Zealand equivalents to International Financial Reporting Standards. References are by Standard and paragraph number or Standard and appendix letter.

The glossary includes the definitions in NZ IFRS 17 *Insurance Contracts*, although it is not yet effective.

The glossary also includes extracts from the New Zealand Equivalent to the IASB *Conceptual Framework for Financial Reporting (2018 NZ Conceptual Framework)* and the New Zealand Equivalent to the IASB *Conceptual Framework for Financial Reporting 2010 (NZ Framework)*. References to the *frameworks* are preceded by 2018 CF and 2010 CF.

References set out in (brackets) indicate minor variations in wording.

<b>12-month expected credit losses</b>	The portion of lifetime expected credit losses that represent the expected credit losses that result from default events on a financial instrument that are possible within the 12 months after the reporting date.	NZ IFRS 9.A

<b>assets held by a long-term employee benefit fund</b>	Assets (other than non-transferable financial instruments issued by the reporting entity) that: (a) are held by an entity (a fund) that is legally separate from the reporting entity and exists solely to pay or fund employee benefits; and (b) are available to be used only to pay or fund employee benefits, are not available to the reporting entity's own creditors (even in bankruptcy), and cannot be returned to the reporting entity, unless either: (i) the remaining assets of the fund are sufficient to meet all the related employee benefit obligations of the plan or the reporting entity; or (ii) the assets are returned to the reporting entity to reimburse it for employee benefits already paid. <b>compensation</b>	Includes all employee benefits (as defined in NZ IAS 19) including employee benefits to which NZ IFRS 2 applies. Employee benefits are all forms of consideration paid, payable or provided by the entity, or on behalf of the entity, in exchange for services rendered to the entity. It also includes such consideration paid on behalf of a parent of the entity in respect of the entity. Compensation includes: <ul style="list-style-type: none"> <li>(a) short-term employee benefits, such as wages, salaries and social security contributions, paid annual leave and paid sick leave, profit-sharing and bonuses (if payable within twelve months of the end of the period) and non-monetary benefits (such as medical care, housing, cars and free or subsidised goods or services) for current employees;</li> <li>(b) post-employment benefits such as pensions, other retirement benefits, post-employment life insurance and post-employment medical care;</li> <li>(c) other long-term employee benefits, including long-service leave or sabbatical leave, jubilee or other long-service benefits, long-term disability benefits and, if they are not payable wholly within twelve months after the end of the period, profit-sharing, bonuses and deferred compensation;</li> <li>(d) termination benefits; and</li> <li>(e) share-based payment.</li> </ul>	NZ IAS 24.9
<b>component of an entity</b>	Operations and cash flows that can be clearly distinguished, operationally and for financial reporting purposes, from the rest of the entity.	NZ IFRS 5.A

<b>constructive obligation</b>	An obligation that derives from an entity's actions where: <ul style="list-style-type: none"> <li>(a) by an established pattern of past practice, published policies or a sufficiently specific current statement, the entity has indicated to other parties that it will accept certain responsibilities; and</li> <li>(b) as a result, the entity has created a valid expectation on the part of those other parties that it will discharge those responsibilities.</li> </ul>	NZ IAS 37.10
<b>contingent asset</b>	A possible asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity.	NZ IAS 37.10
<b>contingent consideration</b>	Usually, an obligation of the acquirer to transfer additional assets or equity interests to the former owners of an acquiree as part of the exchange for control of the acquiree if specified future events occur or conditions are met. <b>cost approach</b>	A valuation technique that reflects the amount that would be required currently to replace the service capacity of an asset (often referred to as current replacement cost).	NZ IFRS 13.A

by considering all contractual terms of the financial asset (for example, prepayment, extension, call and similar options) and expected credit losses. The calculation includes all fees and points paid or received between parties to the contract that are an integral part of the effective interest rate (see paragraphs B5.4.1–B5.4.3), transaction costs, and all other premiums or discounts. There is a presumption that the cash flows and the expected life of a group of similar financial instruments can be estimated reliably. However, in those rare cases when it is not possible to reliably estimate the cash flows or the remaining life of a financial instrument (or group of financial instruments), the entity shall use the contractual cash flows over the full contractual term of the financial instrument (or group of financial instruments).

<b>credit-impaired financial asset</b>	<p>A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired include observable data about the following events:</p> <ul style="list-style-type: none"> <li>(a) significant financial difficulty of the issuer or the borrower;</li> <li>(b) a breach of contract, such as a default or past due event;</li> <li>(c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower’s financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider;</li> <li>(d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation;</li> <li>(e) the disappearance of an active market for that financial asset because of financial difficulties; or</li> <li>(f) the purchase or origination of a financial asset at a deep discount that reflects the incurred credit losses.</li> </ul> <p>It may not be possible to identify a single discrete event—instead, the combined effect of several events may have caused financial assets to become credit-impaired.</p>	NZ IFRS 9.A
<b>credit exposures to an individual counterparty or a group of closely related counterparties</b>	<p>The maximum loss amount that could be incurred under all contracts with that counterparty or group of closely related counterparties in the event of those counterparties failing to discharge their obligations.</p>	NZ IFRS 7.E23
<b>credit loss</b>	<p>The difference between all contractual cash flows that are due to an entity in accordance with the contract and all the cash flows that the entity expects to receive (ie all cash shortfalls), discounted at the original effective interest rate (or credit-adjusted effective interest rate for purchased or originated credit-impaired financial assets). An entity shall estimate cash flows by considering all contractual terms of the financial instrument (for example, prepayment, extension, call and similar options) through the expected life of that financial instrument. The cash flows that are considered shall include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms. There is a presumption that the expected life of a financial instrument can be estimated reliably. However, in those rare cases when it is not possible to reliably estimate the expected life of a financial instrument, the entity shall use the remaining contractual term of the financial instrument.</p>	NZ IFRS 9.A
<b>credit risk</b>	<p>The risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation.</p>	NZ IFRS 7.A

<b>current asset</b>	An entity shall classify an asset as current when: (a) it expects to realise the asset, or intends to sell or consume it in its normal operating cycle; (b) it holds the asset primarily for the purpose of trading; (c) it expects to realise the asset within twelve months after the reporting period; or (d) the asset is cash or a cash equivalent (as defined in NZ IAS 7) unless the asset is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period. <b>deductible temporary differences</b>	Temporary differences between the carrying amount of an asset or liability in the statement of financial position and its tax base that will result in amounts that are deductible in determining taxable profit (tax loss) of future periods when the carrying amount of the asset or liability is recovered or settled. <b>deemed cost</b>	An amount used as a surrogate for cost or depreciated cost at a given date. Subsequent depreciation or amortisation assumes that the entity had initially recognised the asset or liability at the given date and that its cost was equal to the deemed cost.	NZ IFRS 1.A
<b>deferred tax assets</b>	The amounts of income taxes recoverable in future periods in respect of: (a) deductible temporary differences; (b) the carryforward of unused tax losses; and (c) the carryforward of unused tax credits.	NZ IAS 12.5
